The Interim Constitution of Nepal 2007 has maintained the NHRC as a constitutional body, which has a separate sphere of responsibilities in the constitutional legal system of the country. These responsibilities support the responsibilities of the normal machinery of the administration of Justice, the Supreme Court, the Office of the Attorney General, the Commission for the Investigation of Abuse of Authority, and other existing executive, quasi-judicial or judicial bodies of Nepal.				
National Women Commission (NWC)	The National Women Commission (NWC) was established by the Government of Nepal through an executive decision in 2002. The NWC consists of a five-member Commission with a legal mandate to monitor and investigate cases of violence against women (VAW), provide legal aid, monitor the state obligations to UN reporting under CEDAW, coordinate with the government and other agencies for mainstreaming gender policy in national development, and provide recommendations for the reforms through research and monitoring.

European Commission in Nepal (EC-Nepal)	The European Union Commission to Nepal identified three focal areas for EU support to the country in its Country Strategy Paper, one of which is "Stability and Peace Building." Under this framework, a 7 million Euro "Conflict Mitigation Package" was financed in Nepal. This ongoing project aims to enhance the capacity and effectiveness of the Human Rights Commission in monitoring and responding to human rights abuses, and to enhance the capacity of the judiciary in addressing past abuses.
