Voting Advice Applications (VAAs)

VAAs are web applications that ask voters their opinion on relevant political and social issues and then compare these preferences to the position of relevant parties. Their goal, however, is much broader than just giving voting advice, as they aim to increase their users' knowledge about political parties and their positions.

Responding to a real information need on part of the citizens, VAAs enable voters to obtain more background information from party manifestos, websites, and news releases of political parties, through direct links to official documentation which verifies these issue positions or through the use of text boxes which explain more about the issue at stake.

Research shows that this increase in information could then, in turn, have a positive effect on the likelihood of users actually going to the ballots to cast a vote.

EU countries (Germany, Great Britain, Belgium, Poland, Latvia, Greece, Bulgaria, Austria, Italy, Spain, the Czech Republic, Slovakia, France and the Netherlands), which presents a same set of 20 questions to users who, after completing the Vote Match questionnaire in their own country, can click through the results screen to see which parties best represent them in other countries. Their campaign <u>Vote Match</u> launched in occasion of the first European presidential debate.



VoteWatch: Electio2014. Electio2014 is a platform in 24 languages

designed to help the citizens decide which candidate or party to vote for in the 2014 European Parliament elections. The platform was developed by <u>VoteWatch</u> <u>Europe</u>, an independent organisation which monitors and analyses the decision-making activities of the EP and the EU Council of Ministers. By voting on 20 important issues that Members of the European Parliament have also voted on in the last five years, you can find out which sitting MEP or new candidate most closely matches your views.



EUvox 2014. EUVOX is a state-of-the-art, EU-wide VAA for the 2014

elections to the European Parliament. Its purpose is to help citizens to select the political party that best matches their own policy preferences and enable them to have quick access to information about the positions of all parties in these crucial elections. The project has been designed and implemented by a consortium of researchers based on Kieskompas and two PreferenceMatcher, experienced organizations in the field of VAAs that have designed many such tools across four continents. EUvox has been featured in some European news sources such as The Guardian and Trouw.

An online campaign endorsed by a coalition of OSIFE grantees informs the EU migrants of their rights ahead of the European Elections. The initiative focuses on Polish and Romanian Citizens working away from home, in particular those in the UK, Italy and the Netherlands, informing them about the upcoming elections, motivating them to vote and explaining them how to protect their right to work. International Alert launches campaign to strengthen peaceful relations in Europe

The UK-based peacebuilding charity, International Alert, is working with partners in Greece, Italy and the Netherlands to promote a balanced debate around migration and social marginalisation in the run up to the European elections. Barry Navarro, Senior Officer for the UK Programme, said: "In times of austerity and economic crisis, the most vulnerable members of society are often scapegoated. Inflammatory and divisive rhetoric about issues such as migration is increasing, which can fuel tensions between communities". The <u>#eUnify</u> campaign aims to contribute to a more balanced debate and provide a voice for those who are targeted by such attacks, including migrants and minorities. Participation of EU citizens in European Parliament and local elections in Italy

In the framework of the project <u>Operation</u> <u>Vote</u>, a brand-new <u>research report</u> on the political participation of EU movers in Italy has been published last week. It contains recommendations addressed to political parties, associations, local and national institutions aimed at increasing the level of participation of EU movers in the political life of the communities where they reside.
