

## If the Judge Tells You...

If the judge says: "This is my court..."

Say: "Objection! Does this court not belong to the **People** and am I **Not** one of the **People**?"

If the judge says: "Stop talking!"

Say: "I conditionally accept your offer; provided that you can show this court; upon proof of claim, that the Constitution does **Not** afford **every Man** the right to be heard!?"

If the judge says: "Go sit down!"

Say: "I conditionally accept your offer; provided I will be Lawfully and Justly compensated for my time!?! And I will be sitting down by **MY OWN** volition and **NOT** by **ANY Order** given."

If the judge says: "I'm just gonna enter a plea on your behalf..."

Say: "Objection Sir/Madame, You are operation **Ultra Virees** (Outside of your authority). **NO Judge** has the authority to enter **ANY PLEA** on behalf of **Any Man or Woman without their consent**."

If the judge says: "Well, I'm just gonna appoint this attorney to you anyway..."

Say: "I object to this person representing me...I object to this person standing next to me or in my vicinity. Corpus Juris Sercundum has stated; "Anyone who accepts an attorney as representation has made themselves an incompetent, infant and a Ward of the Court." I am **NOT** incompetent, neither am I an infant, nor do I wish to be a ward of this court."

If the judge says: "Do you understand??"

Your answer is **Always**: "**NO!**"

If the judge says: "Who will represent you?"

Say: "No one! I stand before this court **Propia Persona** (in my Proper Person)."

If the judge says: "Are you a sovereign? Are you a sovereign citizen?"

Say: "No! I am an American National."

If the judge says: "What type of law did you study?"

Say: "American Jurisprudence (American Jurisprudence is the conscience of the law)."

If the judge says: "If you are gonna proceed without an attorney, then I will not be able to help/assist you..."

Say: "Objection! That is a **False** statement judge. The law clearly states; "It is the **obligation** of the judge to correct any mis-statements **or** errors in writing made by any litigant. And the litigant **CANNOT** be held to the same standard as an experienced attorney."

If the judge says: "This court is operating under the Constitution of the State of \_\_\_\_\_ and under the U.S Constitution..."

Say: "I object to contracting into any jurisdiction other than the Common Law or the Organic Constitution of the United States of America. Are we operating under Common Law Jurisdiction?"

If the judge says: "Bailiffs, take this person into custody..."

If the judge says: "I have jurisdiction over your body..."

Say: "I object to these proceedings as this court has failed to identify itself on and for the public record." "I conditionally accept your offer provided that bail be set at zero dollars and zero cents and my body be immediately set at liberty."

If the judge says: "I'm gonna hold you in contempt..."

Say: "Forgive me. I wish to remain in honor."

Part 1. If the judge says: "What is your date of birth?"

Say: "My mother told me I was born on \_\_\_\_\_. But I can't say for certain as that is hearsay and I do not wish to perjure myself on the record with hearsay."

Part 2. If the judge says: "Well, I would find that highly unlikely that your mother would lie to you..."

Say: "Well, at one point, I was of the same opinion until I discovered that she had been lying to me about Santa Claus, the Easter Bunny, and the tooth fairy. Unless you are of the belief that they **do exist**?"

If the judge says: "Where do you **live**?"

Say: "I live within the confines of my body. And I Domicile in the free and independent state of New York." (Or whatever state you are at)

If the judge says: "What do you plead; Guilty, Not Guilty, or No Contest?"

Say: "I do not plead, animals plead."

If the judge says: "Do you have any credit/debit cards or a Bank account?"

Say: "No! But my Estate does."

If the judge says: "Do you have a driver's license?"

Say: "No! But my Estate does."

If the judge says: "State your name for the record."
